Terms & Conditions: STORE MAKEOVER RULES AND REGULATIONS

- Contest is open to any qualified retail pet supply store. However, the display habitats to be supplied are mainly suitable for small animals, reptiles, aquatic animals and birds.
- Contestants must complete entry form and bring the completed entry form to the CASCO Giveaway entry box at Booth #3235 (North American Pet) at Global Pet Expo 2011.
- Winners will be notified during the week of March 21st.
- One entry per retail store location and winners must install units in the retail store location on the entry form.
- Winners must be an established independent retail location in the continental United States with a commercial storefront location that sells live animals to the general public. The rights of a winner may not be assigned.
- Compliance with these rules and regulations and any disqualification of a contestant shall be determined by CASCO in its absolute discretion and all such decisions shall be final. Failure to abide by these rules and regulations shall disqualify any contestant. No notification shall be made to any contestant who is determined to be disqualified.
- No purchase necessary. Void where prohibited.
- Employees of CASCO or APPA are not eligible to enter contest.
- Winners will receive display habitats selected by winners from the current catalog of CASCO that are not discontinued items. No special or custom orders will apply. The total habitats selected by winner shall collectively not exceed the retail value of \$25,000 as published by CASCO. In the event the display habitats selected by winner are not equal to CASCO's retail value of \$25,000, winner is not entitled to any additional compensation or other consideration to make up the difference in value received. Winner to pay all delivery expenses including freight before delivery, and shall be responsible to pay all installation costs, and any taxes.
